<p><i>Staff Hourly Rates: If research, manipulation, or preparation of information such as redaction, pixilation, and/or scan time is required, an hourly charge will be assessed if task takes longer than 15 minutes. The hourly rate will depend upon the lowest hourly rate of the employee with the proper security clearance and/or knowledge required to perform the task.</i></p>

<p><i>In some instances, fees may be waived. GRAMA encourages waiving the fee when the request benefits the public rather than a specific individual. GRAMA also encourages the waiver of fees if the requestor is the individual who is the subject of the record - or the guardian. Because GRAMA provides for waivers, a government entity cannot simply state that it will never grant fee waivers. A person who believes that there has been an unreasonable denial of a fee waiver may appeal the denial. If a requestor has not properly paid for previously requested materials, MGFPD will hold the current request until the outstanding payment is paid in full for previous requests.</i></p>
